

## THINK OUTSIDE THE BOX CHALLENGE

### OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS COMPETITION. THE FUTURE ENGINEERS: *THINK OUTSIDE THE BOX* CHALLENGE IS RUN BY FUTURE ENGINEERS, LLC, PO BOX 9043 MARINA DEL REY, CA 90295 (“SPONSOR”). PLEASE NOTE THAT THIS IS NOT A PRIZE DRAW BUT A SKILL-BASED COMPETITION. PLEASE ALSO NOTE THAT THESE OFFICIAL RULES DO NOT CONSTITUTE A TENDER AND TENDER LAW, REGULATIONS AND PRINCIPLES DO NOT APPLY.

THE FUTURE ENGINEERS: *THINK OUTSIDE THE BOX* CHALLENGE IS OPEN TO ELIGIBLE PERSONS BETWEEN THE AGES OF 5 – 19 RESIDING IN THE UNITED STATES. SEE RULE 3 FOR ELIGIBILITY DETAILS.

THE FUTURE ENGINEERS: *THINK OUTSIDE THE BOX* CHALLENGE INVITES ELIGIBLE PERSONS TO SUBMIT A 3D MODELED DESIGN OF AN OBJECT THAT ASSEMBLES OR EXPANDS TO BECOME LARGER THAN THE PRINTING BOUNDS OF THE ADDITIVE MANUFACTURING FACILITY (“AMF”) 3D PRINTER (14CM LENGTH X 10CM WIDTH X 10 CM HEIGHT), LOCATED ON THE INTERNATIONAL SPACE STATION. THE COMPETITION WILL BE COMPRISED OF AN OPEN ENTRY SUBMISSION PHASE (TWO (2) AGE CATEGORIES: JUNIOR ENGINEERS AGES 5-12 AND TEEN ENGINEERS AGES 13-19), SUBMISSION JUDGING TO DETERMINE TEN (10) SEMI-FINALISTS, AND THEN CULMINATING IN A SECOND ROUND OF JUDGING TO SELECT FOUR (4) FINALISTS, FOLLOWED BY AN INTERVIEWING ROUND TO SELECT ONE (1) WINNER IN EACH AGE GROUP.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS COMPETITION. MANY WILL ENTER, FEW WILL WIN.

**1. Competition Dates and Times:** The Future Engineers: Think Outside the Box Challenge competition described in these Official Rules (the “**Competition**”) begins April 16, 2016 at 12:00:01 AM Pacific Time U.S. (“**PT**”), and ends on or about October 6, 2016 at 11:59:59 PM PT (“**Competition Period**”) with the deadline for submission of entries being August 1, 2016 (11:59:59 PM PT). For the purposes of these Official Rules, a “day” shall begin at 12:00:01 AM PT and end at 11:59:59 PM PT. The Future Engineers computer runs the official clock for the Competition and will solely determine the time by which an entry is received. During the Competition Period there are a series of events which start and end on or about the dates and times noted below:

**2. Competition Entities: Future Engineers, LLC, PO BOX Marina Del Rey, CA 90295 (“Sponsor”). Marden-Kane Inc., 195 Froehlich Farm Blvd, Woodbury, NY 11797 (“Competition Administrator”).** Sponsor, Partners and Competition Administrator are collectively referred to as the **“Competition Entities”**.

**3. Eligibility:** Participation in this Competition is open to individuals who are between the ages of 5 – 19 on the date of submission of an Entry (as defined below), who are legal residents of the 50 United States or the District of Columbia and are enrolled in a U.S. public elementary, secondary school (grades K-12), private or home school, on April 16, 2016. If under the age of majority in his/her residents, an eligible person must have his/her parent’s or legal guardian’s permission to enter this Competition. Sponsors reserve the right to verify an individual’s eligibility to participate in the Competition (including, without limitation, that the individual has his/her parent’s or legal guardian’s permission to enter this Competition, if applicable) by requesting proof of identity and/or eligibility in a form acceptable to Sponsors (including, without limitation, government issued photo identification). At any time during the Competition, Competition Administrator reserves the right to request minor Entrant to provide a signed consent form of a parent/legal guardian agreeing to the provisions of this section, as well as the terms and conditions of these Official Rules. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification. **Minors – Parents and Guardians:** The parent(s) or legal guardian(s) of an Entrant under the legal age of majority in his/her jurisdiction of residence: (a) will ensure that the Entrant in respect of whom they agree to these Official Rules will comply with these Official Rules; and (b) warrants that he/she agrees to these Official Rules and gives the consents contained herein, including permission for his/her child/ward to participate in this Competition. The parent(s) or legal guardian(s) of each such Entrant agrees to indemnify the Released Parties (as defined below) for and against: (a) any claims made by the Entrant, his or her legal guardian(s), or any member of his or her family against the Released Parties in connection with the Competition; and (b) any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules.

**Ineligibility:** Employees, officers, directors, agents, representatives and their immediate family members (which means parents, spouses, children, siblings, in-laws, grandparents and grandchildren and their respective spouses, regardless of where they reside) or residents in the same household (whether legally related or not) of the Competition Entities and their respective parents, affiliated and subsidiary companies, advertising and promotion agencies, legal and financial advisors, any and all other companies associated with this Competition (including other institutions listed on the Competition Site who are involved in judging), are not eligible to enter or otherwise participate in this Competition.

#### **4. How to Enter the Competition:**

##### **Individual entries only (team entries will be disqualified) -**

***Step 1 – Registration: Create a Future Engineers Student Member Account*** - Each individual participating in this Competition shall be referenced herein as an “**Entrant**”. Entrants must first create a Future Engineers Student Member Account (“**Student Account**”). To create a Student Account, Entrants must register and submit their “**Registration Form**” (registration) online at the Competition site, [www.futureengineers.org](http://www.futureengineers.org) (the “**Competition Site**”). An entrant can initiate the registration process by providing the following pre-registration data to the Competition Site.

Required pre-registration information by age group:

- **If Entrant is between 5 and 12 years of age** you will be asked to enter your date of birth, create a username and password (confirm password) and provide your parent or legal guardian’s email address during the Registration process. (refer to Step 2 (i) below for parent instructions). We encourage parent’s/legal guardian’s to assist the entrant’s in this pre-registration process.
- **If Entrant is between 13 and 17 years of age** you will be asked to enter your date of birth, create a username and password (confirm password), your (entrant’s) e-mail address and your parent or legal guardian’s email address during the pre-registration process. (refer to Step 2 (ii) below for parent instructions)
- **If Entrant is 18 or 19 years of age** you will be asked to provide your date of birth, create a username and password (confirm password) and your (entrant’s) e-mail address during the pre-registration process

As part of the pre-registration process, potential Entrants will be required to click where indicated to agree that they are currently enrolled as a K-12 student in a United States school.

***Step 2 (i) – Entrant between the ages of 5 and 12 at time of registration - Parent/Guardian Consent to Create a Student Account:*** Upon receipt of the pre-registration data, the Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address that the Entrant provided during registration. The Sponsor reserves the right to verify any parent’s/guardian’s e-mail address at its sole discretion and Sponsors’ inability to verify such e-mail address may result in disqualification of Entrant.

Parent(s)/guardian(s) consent is a requirement for Entrants deemed minors in the area where they reside. Parent(s)/guardian(s) must complete profile page (including Students First and Last Name, Student Grade, Student Gender, Parent/Guardian Name, Parent/Guardian current address including; Street, City, State, Zip, Parent/Guardian phone number, and student e-mail (optional)) and click to “Accept” the Privacy Policy and Terms & Conditions of the site. Parent/Guardian will give consent to create an Account that will remain active for subsequent Future Engineer Challenges. Parent/Guardian may opt-out of Student Account at any time by e-mailing admin@futureengineers.org.

**Step 2 (ii) – Entrant between the ages of 13 and 17 at time of registration - Parent/Guardian Consent**

**to Create a Student Account:** Upon receipt of the Registration, the Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address that the Entrant provided during registration. The Sponsor reserves the right to verify any parent’s/guardian’s e-mail address at its sole discretion and Sponsors’ inability to verify such e-mail address may result in disqualification of Entrant.

Parent(s)/guardian(s) consent is a requirement for Entrants deemed minors in the area where they reside. Parent(s)/guardian(s) must complete profile (including Students First and Last Name, Student Grade, Student Gender, Parent/Guardian Name, Parent/Guardian current address including; Street, City, State, Zip, Parent/Guardian phone number, and student e-mail (optional)) page and click to “Accept” the Privacy Policy and Terms & Conditions of the site. Parent/Guardian will give consent to create a Student Account that will remain active for subsequent Future Engineer Challenges. Parent/Guardian may opt-out of Student Account at any time by e-mailing admin@futureengineers.org.

**Step 2 (iii) – Entrant between the ages of 18 and 19 at time of registration – Create a Student Account:**

Entrant must complete profile page (including Students First and Last Name, Student Grade as of (April 16, 2016), Student Gender, Street, City, State, Zip, Student phone number, and student e-mail) and click to “Accept” the Privacy Policy and Terms & Conditions of the site. Entrant will give consent to create a Student Account that will remain active for subsequent Future Engineer Challenges. Entrant may opt-out of Student Account at any time by e-mailing admin@futureengineers.org.

**Step 3 – Registration: Join the Challenge** –Entrant with a Student Account clicks where indicated to initiate participation in the Competition.

As part of the registration and entry process for participation in the Competition, potential Entrants will be required to click where indicated to signify that the student was enrolled in a K-12 school in the United States, on April 16, 2016, and they have read, understood, accept, and agree to be bound by these Official Rules and the terms hereunder, including but not limited to the releases of liability, and including the Entrant’s acceptance of the decisions of the Competition Entities and the Judging Panel as defined in Rule #4 (which, notwithstanding any term of these Official Rules or the Competition Site, are final and binding in all respects, without prejudice of any claim that could be filed before the Court).

**Step 4 (i) – Entrant between the ages of 5 and 12, as of April 16, 2016 - Parent/Guardian Consent to Participate in Challenge:**

Upon receipt of the request to join a challenge, the Sponsor will assign each Entrant to one of two age categories, 5-12 or 13-19 based on their age as of April 16, 2016. Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address listed in their student account. The Sponsor reserves the right to verify any parent's/guardian's e-mail address at its sole discretion and Sponsors' inability to verify such e-mail address may result in disqualification of Entrant. Parent(s)/guardian(s) consent is a requirement for Entrants deemed minors in the area where they reside. Parent(s)/guardian(s) must click to "Accept" the terms of the online consent, including (a) that they will comply with these Official Rules, (b) a warranty that they are capable of agreeing to these Official Rules and giving the consents contained herein, (c) an agreement to indemnify the Released Parties for and against any claims made by the Entrant, or any member of his/her family against the Released Parties in connection with this Competition and any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules by a designated date/time before an Entrant is eligible to submit an entry. Sponsors may send one reminder e-mail, and one "Last Chance" reminder e-mail, to Entrants or parent(s)/guardian(s) in event consent deadline is near.

**Step 4 (ii) – Entrant between the ages of 13 and 19, as of April 16, 2016 - Parent/Guardian Consent to Participate in Challenge:**

Upon receipt of the request to join a challenge, the Sponsor will assign each Entrant to one of two age categories, 5-12 or 13-19 based on their age as of April 16, 2016. Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address listed in their student account. The Sponsor reserves the right to verify any parent's/guardian's e-mail address at its sole discretion and Sponsors' inability to verify such e-mail address may result in disqualification of Entrant. **Step 4 (iii) – Entrant between the ages of 18 or 19, as of April 16, 2016 - Consent to Participate in Challenge:**

Upon receipt of the request to join a challenge, the Sponsor will assign each Entrant to one of two age categories, 5-12 or 13-19 based on their age as of April 16, 2016. Sponsor will e-mail the Entrant using the e-mail address listed in their student account. The Sponsor reserves the right to verify any e-mail address at its sole discretion and Sponsors' inability to verify such e-mail address may result in disqualification of Entrant. Entrants must click to "Accept" the terms of the online consent, including (a)

that they will comply with these Official Rules, (b) a warranty that they are capable of agreeing to these Official Rules and giving the consents contained herein, (c) an agreement to indemnify the Released Parties for and against any claims made by the Entrant, or any member of his/her family against the Released Parties in connection with this Competition and any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules by a designated date/time before an Entrant is eligible to submit an entry. Sponsors may send one reminder e-mail, and one “Last Chance” reminder e-mail, to Entrants or parent(s)/guardian(s) in event consent deadline is near.

**With assistance from a Teacher/Educator -**

**Step 1 – Teacher/Educator Registration:** Each individual Teacher/Educator (from a class, camp or workshop, or any organized group) representing a group of students participating in the Competition shall be referenced herein as a “**Teacher Representative**”. Teacher Representatives must Register for a Future Engineers Teacher Member Account and submit their “Registration Form” (registration) online at the Competition site, [www.futureengineers.org](http://www.futureengineers.org) (the “**Competition Site**”). Teacher Representatives must complete profile page including; First and Last Name, E-mail Address, Phone Number, School Name, School City, School State, and will be asked to create a unique Username and Password. Teacher Representative will be required to accept the Privacy Policy & Terms and Conditions of the Site. Teacher Representative will be required to accept that as a Teacher/Educator they will be assisting students with registration and submission of their entries.

Upon completion of Registration, the Teacher Representative will be assigned a unique teacher code and re-directed to an Admin Panel.

Entrants participating with teacher assistance in a class may enter their teacher’s unique code when joining a challenge. Entrants with a linked teacher code may choose to submit an entry individually, or may choose to allow a teacher to submit an entry on their behalf.

**If Entrant is between 5 and 12 years of age**, entrant will enter their unique teacher code during Step 3 above. Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address listed in their student account. Parent(s)/guardian(s) consent is a requirement for Entrants deemed minors in the area where they reside. Parent(s)/guardian(s) must click to “Accept” teacher assistance and the terms of the online consent, including (a) that they will comply with these Official Rules, (b) a warranty that they are capable of agreeing to these Official Rules and giving the consents contained herein, (c) an agreement to indemnify the Released Parties for and against any claims made by the Entrant, or any member of his/her family against the Released Parties in connection with this Competition and any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules by a designated date/time before an Entrant is eligible to submit an entry. Sponsors may send one reminder e-mail, and one “Last Chance” reminder e-mail, to Entrants or parent(s)/guardian(s) in event consent deadline is near.

**If Entrant is between 13 and 17 years of age** entrant will enter their unique teacher code during Step 3 above. Sponsor will e-mail the parent(s)/guardian(s) of the Entrant to the e-mail address listed in their

student account. Parent(s)/guardian(s) consent is a requirement for Entrants deemed minors in the area where they reside. Parent(s)/guardian(s) must click to “Accept” teacher assistance and the terms of the online consent, including (a) that they will comply with these Official Rules, (b) a warranty that they are capable of agreeing to these Official Rules and giving the consents contained herein, (c) an agreement to indemnify the Released Parties for and against any claims made by the Entrant, or any member of his/her family against the Released Parties in connection with this Competition and any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules by a designated date/time before an Entrant is eligible to submit an entry. Sponsors may send one reminder e-mail, and one “Last Chance” reminder e-mail, to Entrants or parent(s)/guardian(s) in event consent deadline is near.

**If Entrant is 18 or 19 years of age**, entrant will enter their unique teacher code during Step 3 above. Sponsor will e-mail the Entrant to the e-mail address listed in their student account. Entrant must click to “Accept” teacher assistance and the terms of the online consent, including (a) that they will comply with these Official Rules, (b) a warranty that they are capable of agreeing to these Official Rules and giving the consents contained herein, (c) an agreement to indemnify the Released Parties for and against any claims made by the Entrant, or any member of his/her family against the Released Parties in connection with this Competition and any losses (including any liability) caused by any conduct of the Entrant which is inconsistent with these Official Rules by a designated date/time before an Entrant is eligible to submit an entry. Sponsors may send one reminder e-mail, and one “Last Chance” reminder e-mail, to Entrants or parent(s)/guardian(s) in event consent deadline is near.

**5. How to Submit an Entry:** Entrant and/or Teacher Representative (on behalf of Student) may submit one (1) original 3D model creation in response to the request to “Design a 3D model of an object that assembles or expands to become larger than the printing bounds of the Additive Manufacturing Facility 3D printer, located on the International Space Station (14cm length x 10cm width x 10cm height).” (subsequent entries will be disqualified). The entry must include (i) an image of your assembled 3D model of an object that assembles or expands to become larger than the printing bounds of the Additive Manufacturing Facility 3D printer (14cm length x 10cm width x 10cm height), (ii) a 3D model of your object in its 3D print layout (smaller than or equal to 14cm length x 10cm width x 10cm height), (iii) a 3D model of your object in its assembled or expanded configuration (larger than 14cm length x 10cm width x 10cm height), (iv) a Title of your Object (maximum 20 characters), and (v) Description/Use of your Object on the International Space Station (maximum 100 characters). The submission must follow the technical, creative, and legal entry requirements explained in Rule #5 below (an “**Entry**”).

Registration and Entry may be submitted anytime during the “Open Call for Entries” (See Rule #1) at <http://www.futureengineers.org/>. Entries not submitted in accordance with the instructions provided on the Competition Site and in these Official Rules may be disqualified, at the sole discretion and determination of the Competition Entities.

**Submissions that do not execute the Submission Material dimensions will be displayed, but ineligible to win.**

All eligible Entries will be scored by a panel of independent judges (each, a “Judge” and collectively, the “Judges” or “Judging Panel”), who will select the top-scoring Entries, which will be deemed Semi-Finalists (see Rule #7). Semi-Finalist Entries will be scored by a panel of independent judges (see Rules #8 and #9) to determine Finalists. Finalists will be interviewed by a panel of independent judges via a Google Hangout or Skype. Following the completion of the interviews the panel of judges will determine the Winner in each age category.

## **6. Entry Requirements and Design Guidelines:**

### Entry Requirements:

- Image of your assembled or expanded Object in its final configuration
  - File must be JPG or JPEG file format
  - Maximum file size 500KB
- 3D Model of your Object in its 3D print layout (smaller than or equal to 14cm length x 10cm width x 10cm height)
  - File must be an STL file format
  - Maximum file size 20MB
- 3D Model of your Object in its assembled or expanded configuration (larger than 14cm length x 10cm width x 10cm height)
  - File must be an STL file format
  - Maximum file size 20MB
- Title of your Object (maximum 20 characters)
- Text Description/Use of your Object on the International Space Station (Maximum 1000 characters)
- Submission must be an original 3D modeled creation and idea of the Entrant
- Design must not include inappropriate design elements, written content that is likely to be considered offensive (all submissions will be censored before they are posted online)
- Submissions may not infringe or violate the rights of any third party, including but not limited to, copyrights, trademarks, patents, trade secrets, logos, contract and licensing rights, rights of publicity or privacy, moral rights, image rights, or any other intellectual property rights
- For the protection of student safety, the entry may not include any personally identifiable information such as a student name or username.
- For the protection of personal privacy, the entry may not include any personally identifiable information of others.
- Entry must be submitted in English

**Entries that have been reviewed and found in compliance with these rules may be displayed on the Future Engineers gallery page at the sole discretion of the Contest Entities. Submissions that do not execute the Submission Material dimensions will be displayed, but ineligible to win.**

### Design Guidelines:



Entrants are encouraged to use the Think Outside the Box Challenge Design Guidelines provided at [www.futureengineers.org](http://www.futureengineers.org). Failure to comply with these Guidelines will not disqualify an entry, but may result in lower scores by the judges.

**7. Entry Terms:** By entering, Entrants (and if eligible minors, their parents/legal guardians) agree to comply with these Official Rules and Privacy Policy ([www.futureengineers.org/pdfs/PrivacyPolicy.pdf](http://www.futureengineers.org/pdfs/PrivacyPolicy.pdf)). By entering, each Entrant (and, if an eligible minor, his/her parent/legal guardian) represents and warrants that his or her Entry conforms to these Official Rules, the requirements of the Competition Site, and

- (i) does not contain any use of the names, or other identifying elements, in whole or in part, of any person, living, or dead, except as required to cite sources used as part of the Entry;
- (ii) does not include trademarks, logos, emblems or copyrighted material not owned by Entrant (including but not limited to company names) or otherwise infringe or violate the rights of any third party, including but not limited to, copyrights, trademarks, patents, trade secrets, logos, contract and licensing rights, rights of publicity or privacy, moral rights, or any other intellectual property rights;
- (iii) is not subject to any third party agreement(s) and no third party consents and/or licenses are required in connection herewith, and that the Competition Entities will not be required to pay or incur any sums to any person or entity, including without limitation, any copyright collecting societies or holders of copyrights, neighboring rights, or moral rights, or persons representing such, and any person acting on their behalf as a result of its use or exploitation of the idea, Entry materials or rights therein;
- (iv) does not defame, misrepresent, or contain disparaging remarks or any other content which could adversely affect the name, reputation or goodwill of the Released Parties or any other individuals and/or entities;
- (v) does not contain pornographic or sexual content, hateful content of any kind (including racism, sexism, etc.), content which promotes violence or harm to another living creature, or any other offensive, obscene or inappropriate content;
- (vi) does not include threats of any kind or that intimidate, harass, or bully anyone; and
- (vii) does not violate any local, state, or national law or post any content that would encourage or provide instructions for a criminal offense;

Competition Administrator reserves the right to disqualify any Entrant who, in their sole discretion, they determine has violated the Official Rules of this Competition or breached a representation (scientific or otherwise) or warranty at any time during the Competition.

Competition Administrator understands that this is a K-12 student competition and that errors may occur in the submission process that is honest misunderstanding of the official rules. The intent of the administration is to acknowledge, display, and encourage student participation in the competition while administering a fair competition without coaching or assistance. For this reason, Contest administration reserves the right to allow each student entrant one valid submission to the challenge during the open submission period. In the event that an ineligible entry is received, competition administration will

reject the entry with no explanation of why the entry was ineligible, but will allow the student to resubmit BEFORE the submission deadline of August 1, 2016.

In the event that a submission was received that is deemed to be intentionally rude, vulgar, inappropriate, or illegal the administrators will not allow resubmission and the entrant will be immediately disqualified from the competition.

Entries that do not comply with these Official Rules as determined by Competition Entities, in their sole discretion, will be disqualified from the Competition and will not appear on the Competition Site. Entrant (and if an eligible minor, his/her parent/legal guardian) agrees that Released Parties (as defined below) are not responsible for any unauthorized use of Entries by third parties. Additionally the Judging Panel may select up to five (5) alternates per age group (each, an “**Alternate**”).

In the event of a tie, all tied eligible Entries will be independently re-evaluated by a tie-breaking Judge using the Judging Criteria above to break the tie. The Judging Panel’s decisions are final and binding in all matters relating to the Competition.

**Potential Semi-Finalist & Alternates Notification: The Potential Semi-Finalists and Alternates will be notified of their selection via e-mail on or about August 16, 2016 and they (or if eligible minors, their parents/legal guardians) will be required to sign and properly execute the following documents and return them via e-mail or facsimile (and subsequently by mail to Competition Administrator):**

  - (2) An Entrant Agreement and Release;

The Judging Panel will identify the four (4) highest scoring Entries per age group (5-12, 13-19) and these Entrants will be deemed the “Potential Finalists”.

In the event of a tie, all tied eligible Entries will be independently re-evaluated by a tie-breaking Judge using the Judging Criteria above to break the tie. The Judging Panel’s decisions are final and binding in all matters relating to the Competition.

**10. Judging to Determine Winners.** An independent Judging Panel comprised of high profile individuals selected by Future Engineers, LLC, will virtually interview each Finalist via Skype, Hangout, or a similar online interview platform. Finalists will be expected to be available for an interview on a date and time agreed to with sponsor. Selected or all Interviews will be posted online for public viewing at Sponsor’s discretion. The judging to determine winners begins on or about September 29, 2016 and ends on or about October 4, 2016. The highest scoring Finalists for each age group (5-12, 13-19) will be deemed the “**Winners**”, subject to verification of eligibility and compliance with these Official Rules.

Designation as a Finalist or a Winner is subject to verification of eligibility and proof of compliance with these Official Rules, maintaining compliance with these Official Rules and approval by the Sponsors. Entrant will retain ownership to his/her Entry subject to the version of the Future Engineers Terms of Service. However, by entering the Competition, and to the extent allowed by law, Entrants (and if eligible minors, their parents/legal guardians) grant the Competition Entities (and companies associated with this competition) and their respective affiliates, licensees, promotional partners, developers, legal representatives, assigns, agents and licensees (collectively, the "**Licensed Parties**"), a perpetual royalty-free, non-exclusive, sub licensable, unconditional and transferable license to print, edit, manipulate, re-create, alter, modify, cut, rearrange, add to, delete from, reproduce, encode, store, copy, transmit, publish, post, broadcast, display, adapt, create derivative works and compilation works from (Participants acknowledge that the Sponsor and companies associated with this competition may be required to manipulate, re-create, alter, and/or modify submissions, exhibit and/or otherwise use or reuse (without limitation as to when or to the number of times used)), the Entry, statements, including, but not limited to, all materials submitted in connection with the Competition, as well as any additional photographic images, video images, portraits, documents, interviews or other materials relating to the Entrant and arising out of his/her participation in this Competition (with or without using the Entrant's name) in any and all media, including but not limited to print, digital and electronic media, computer, cell phone, DVD, CD, TV, social media, radio, audio and audiovisual media (whether such media is now existing or hereafter devised), in any manner, for trade, advertising, promotional, commercial, or any other purposes in connection with this Competition and the use of the Entry, without further review, notice, approval, consideration, or compensation to Entrant or any third party.

In the event that the waiver of moral rights as stipulated above is unenforceable or invalid, Entrants (and, if eligible minors, their parents/legal guardians) thereby acknowledge and agree that Competition Entities are authorized to exercise all moral rights to the Entries, including but not limited to a right to publish, alter and adapt such Entries, and, where applicable, also to join such Entries with other works of mind, and include such Entries into a collective work or database. ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE COMPETITION IS A VIOLATION OF THE LAW AND, SHOULD SUCH AN ATTEMPT BE MADE, THE COMPETITION ENTITIES AND EACH OF THEIR LICENSEES RESERVE THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON(S) RESPONSIBLE FOR ANY SUCH ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. NOTWITHSTANDING THE REVIEW OF ANY ENTRY BY THE COMPETITION ADMINISTRATOR, EACH ENTRANT (AND, IF AN ELIGIBLE MINOR, HIS HER PARENT/LEGAL GUARDIAN) UNDERSTANDS AND AGREES TO BEAR SOLE LIABILITY FOR THE CONTENTS OF HIS/HER ENTRY AND AGREES TO REIMBURSE THE RELEASED PARTIES FOR ANY DAMAGES AND/OR COSTS INCURRED AS A RESULT OF A THIRD PARTY'S CLAIM OR DEMAND RELATING TO THE CONTENT**

**17. General Conditions:** The Competition Entities' and Judging Panel's decisions are final and binding in all matters relating to this Competition, including interpretation and application of these Official Rules (without prejudice of any claim that could be filed before the Court). The arbitration shall be conducted in Los Angeles, California, and the Federal Arbitration Act, and not any state law concerning arbitration, shall apply. The arbitration award shall be final and exclusive, and the prevailing party in the arbitration may file an action in court to confirm and to enforce the arbitration award. Any such action, or any claim, cause of action or proceeding not subject to arbitration as set forth in this section, shall be filed and adjudicated in a state or federal court in Los Angeles County, California, and all parties agree to submit to the personal jurisdiction of those courts. Entrants irrevocably waive any rights to seek and/or obtain injunctive or other equitable relief and any defense of forum non conveniens.
